- **b.** Neighbourhood Plan Following discussion it was proposed by PA 2nd MW and all agreed that we do a further big push for a public meeting at Lewannick. It was planned to hold this parish meeting prior to our ordinary meeting on Tuesday 21 February. A separate flyer will go out to each household and this will be attached to our monthly newsletter.
- **c. Plusha Junction** The Chair moved that this item be discussed in closed committee.
- **d.** Polyphant Green management It was proposed by MW 2nd JP and all in agreement that we purchase a sign to place by the former pond warning people that there is standing water. Our maintenance contractor had confirmed that the water was the only source on the green and it does encourage a number of frogs and is beneficial for the ecology balance.
- e. Confirmation of meetings to be held on a Tuesday and change to standing order. It was proposed by SD 2nd SC that we change our standing order to the third Tuesday of every month. No meetings in August and December. All were in agreement.
