Thank you for forwarding the response from South West Water (SWW) Property Department regarding your letter to them dated 24 January 2018.

Please accept my apologies for any confusion regarding receipt of this letter. Standard procedure is for all written correspondence to be logged by the Administration Department and passed to the Written Correspondence Department in order to respond. Unfortunately in this instance it appears that our Post Room passed your letter directly to the Property Department, bypassing the logging process. When asked if we had received any written correspondence from Lewannick Parish Council I checked with our Administration Department who confirmed that nothing had been logged.

The person who responded to your enquiry is the Property Sales Co-ordinator. They checked SWW records but there was no reference to SWW's involvement with the sign in question. As all SWW signs are produced with the company logo and corporate design, this is why the response you received informed you that the sign was not SWW's.

SWW does not have any record of a specific instruction to install a sign at the entrance to the lane. It is possible that the contractors may have suggested erecting a sign following the reinstatement of the lane when the capital scheme was delivered in 2008. Unfortunately we are unable to confirm this with the contractor as they no longer exist. I have asked my colleagues who were involved with the capital scheme; however none of them have any recollections of this sign.

In terms of SWW's usage of the lane it is fairly minimal. Large tankers will only need to access a Sewage Pumping Station (SPS) for operational emergencies. Our records confirm that only one tanker has accessed the lane within the last twelve months. This was on 5 August 2017 when a post was driven through a rising main causing a pollution incident. Smaller maintenance vehicles will also access the lane. SWW records confirm that seven such vehicles have accessed the SPS within the last three months.

Lewannick Church – Tower Clock

Further to our engineers' recent visit to site we are pleased to submit the following details & suitable quotation.

On arrival he found the clock to be stopped at 4.55, he felt this was due to the stop work on the strike having jammed following a power failure; the strike was partly through the twelve-strike sequence. He re-started the movement & set to time.

On close examination he found the arm on the auto-regulator [this provides the accurate time keeping] to be cracked, this was stopping it from working, this will be replaced under warranty.

He also found the dial motion works on the south dial, have dropped causing the hour tube to rub on the stonework, this is caused by the failure of the fixings which hold the timber supports in position. This will affect the time keeping of the movement. We need to move the timber supports back into position & re-fix using non-ferrous fixings & are pleased to submit a quotation for this work.

In our work to obtain / manufacture new timber support fixings.

To attend on site, approach the south dial, dial motion works using our ladders, position the dial motion work timbers back into position, re-secure using non-ferrous fixings. Check the dial motion works to ensure they are working correctly.



Good Morning,

I would like to formally apply for the vacant position of Parish Councillor on Lewannick Parish Council.

Before moving to Polyphant three years ago, I was a Renal Ward Administrator at Kings College Hospital for six years, prior to that I worked at The Wellington Hospital, St. John's Wood, as a Ward Administrator for eight years.
